1. Origin of the works:

- The artist declares that the works are his original creations, and that he owns all rights on them.
- All rights on the works remain the property of the artist. They shall not be sold, licensed or otherwise dealt with by the gallery without the written authorization of the artist.
- In appendix a list with all works in this consignment with all necessary indications.

2. Insurance:

- For the duration of the consignment, the works are insured by the gallery against fire and related damage for the value of replacement or recreation, and this to a limit of 2500 Euro.
- Are not insured: theft, breaking of the glass, discoloration due to light and normal environmental influences, production faults (e.g. bad mounting)

3. Expenses:

- No costs will be incurred by either party in the name of the other party, without written consent from the party liable for the costs.
- The Gallery will be responsible for any costs involved in the exhibition, framing and matting, promotion and sale of the works for the period of the consignment.
- The Artist will be responsible for all costs associated with producing all art works, documentation and authentication.
- For solo exhibitions, the artists pays a fixed price of 25 Euro per week/weekend of exhibition. For participation at art fairs, a separate agreement will be made.

4. Sale:

- The artist appoints the gallery as his agent for the purposes of exhibition and sale of the consigned works in the attached list of works. This agreement does not make the gallery the exclusive agent for any work of the artist on any location or exhibition.
- The sales price of each work is set by the artist in consultation with the gallery as described in the attached list.
- The gallery will place 2/3 mark up on the cost price before eventual taxes as commission. The cost price plus gallery mark up and eventual taxes will total the recommended retail price advertised to the public. (Commision = 40% of Sales price.)
- For the duration of this agreement and a reasonable time afterwards, the artist shall not sell or offer the same or comparable other works at a lower price than the gallery sales price.
- A sales reduction of 5 to max. 10% can be given by the gallery to museums, decorators, or combined purchases of multiple artworks.
- All works remain the property of the artist until they are sold. With the sale of a work, the ownership is transferred directly from the artist to the buyer. In the event of a bankruptcy of the gallery, these works are not part of the inventory and can not be sold to pay the debts.

5. Payment:

- The artist is informed of the sale of a work. Within 30 days, payment of the artist cost price, as mentioned in the consignment list, is made to his bank account.

6. Website and publicity:

- The artists provides his biography and low resolution digital images of the works for publication on the gallery website www.kr-line.com
- The gallery is responsible for the lay-out and content of the website.
In consultation with the gallery and the artist one or more images are selected for the exhibition publicity. These images are delivered in high resolution to the gallery and may only be used for the purpose mentioned above.

7. Duration:

- This agreement is valid for 1 year starting at/...../.....
- The contract will automatically be renewed. After this year, the artist or the gallery can end the agreement at any time simply by mail or email, giving the gallery 6 weeks time to remove artworks from exhibition and return them to the artist.

8. Contract Alteration

- This agreement constitutes the entire understanding of the parties. It cannot be changed without the written permission of both parties.
